


I have cc'd Mike Sam on this message so that he is brought into the conversation as well.</p> <p>I have finally heard back from SAGE and they outlined the challenges they face given a new government regulation that is impeding SAGE from supporting sales of products that contain an electronic component to Taiwan customers who do not have a VAT number.</p> <p>They have communicated that they cannot invoice for combined print and online subscriptions to Taiwanese customers anymore. They're only able to provide print only subscriptions to Taiwanese members.</p> <p>There is currently no IRSS print-only option and <b>ISSA</b> will need to work through a price for print-only membership. We will be moving forward on that early in the new year.</p> <p>This certainly doesn't help you in this moment. SAGE is aware these memberships are urgent and is suggest that we provide you with a print only membership free of charge for the first 2 issues of the year, while we sort this out.</p> <p>Is this a helpful short-term solution for you?
